On 19 June 2015, an aggregate of 446,000,000 new Shares have been issued to the Subscriber, Shagang International (Hong Kong) Co., Limited, at the Subscription Price of HK\$1.12 per Subscription Share pursuant to the Share Subscription Agreement signed on 7 May 2015, and the net proceeds are approximately HK\$449.3 million.

On 30 June 2015, an aggregate of 754,000,000 Placing Shares have been successfully placed by the Placing Agent to not less than six Placees at the Placing Price of HK\$1.12 per Placing Share pursuant to the terms and conditions of the Placing Agreement signed on 7 May 2015, and the net proceeds are approximately HK\$836.7 million.
