PROFIT WARNING

This announcement is made by Honbridge Holdings Limited (the “**Company**”) and its subsidiaries (collectively, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on the GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) of Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong) (the “**SFO**”).

The board of directors (the “**Board**”) of the Company wishes to inform the shareholders of the Company and potential investors that, based on the currently available information which includes, but without limitation to, the unaudited management accounts of the Group, the Group is expected to record approximately HK\$12.0 million revenue for the period ended 31 March 2022 (“**First Quarter of 2022**”), decreased by approximately 87% when compared to the approximately HK\$94.0 million revenue for the period ended 31 March 2021 (“**First Quarter of 2021**”). The substantial decrease in revenue was mainly due to the decrease in demand of lithium-ion batteries from our major customer Volvo Car while new lithium-ion battery product of the Group is not expected to commence mass production until mid-2022.

In the First Quarter of 2022, the loss attributable to the owners of the Company was approximately HK\$56.0 million (First Quarter of 2021: HK\$155.0 million profit). The change from profit to loss was mainly due to the decreased in share price of a financial

asset at fair value through profit or loss during the First Quarter of 2022, generated approximately HK\$49.0 million non-cash other operating expense (First Quarter of 2021: approximately HK\$109.0 million profit) and decreased in gross profit. On the other hand, a HK\$45.4 million gain on disposal of a financial asset at fair value through profit or loss was recognised for the First Quarter of 2021 but there was no such one-off income in the First Quarter of 2022.

As the Company is still in the process of finalising the unaudited consolidated financial results of the Group for the First Quarter of 2022 (the “**2022 First Quarterly Results**”), the information contained in this announcement is based on a preliminary assessment made by the Board with reference to the information most currently available including the Group’s latest consolidated management accounts, and such information or figures are subject to the review by the Audit Committee and the actual results of the Group for the First Quarter of 2022 may differ from the information disclosed herein. Shareholders of the Company and potential investors are advised to read carefully the announcement to the 2022 First Quarterly Results which is scheduled to be published on 10 May 2022.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.
